

This Privacy Policy governs the manner in which T&E Neville Ltd and Neville Special Projects Ltd (hereafter referred to as Neville Construction Group) collects, uses, maintains and discloses information collected from users (each, a "User") of the <http://www.nevilleconstruction.co.uk> website ("Site"). This privacy policy applies to the Site and all products and services offered by Neville Construction Group.

## Data Privacy laws changed on 25 May 2018

This notice sets out most of your rights under the new laws.

### Personal identification information

We may collect personal identification information from Users in a variety of ways in connection with activities, services, features or resources we make available on our Site. Users may visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personally identification information, except that it may prevent them from engaging in certain Site related activities.

The type of personal information we will collect from you is:

- a) Your name
- b) Your address and telephone number
- c) Your email address

### Non-personal identification information

We use Google Analytics to collect information about how visitors use our website. It provides us with anonymous information including the numbers of visitors to the website, where they visit, the browsers used and for what length of time. We do not use this data in any way to identify specific users or to discover any personally identifiable information about our users.

We will always be transparent about any data we receive from the website.

### Web browser cookies

Our Site may use "cookies" to enhance User experience. User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. User may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of the Site may not function properly.

## Why we collect your personal information and how we use it

The information we hold on you will be used to provide a service you have requested, inform you of updates you've asked for or if we need to obtain or provide additional information.

## How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our Site. We do not send any personal data outside of the EEA (European Economic Area).

## How long we keep your personal information

We will keep your personal information as long as we require it to complete our services to you as requested.

We may keep your data for up to 10 years for one of the following reasons:

- To respond to any questions or complaints
- To show that we treated you fairly
- To maintain records according to rules that apply to us as a business

We may keep your data for longer than 10 years if we cannot delete it for legal, regulatory or technical reasons. We may also keep it for research or statistical purposes. If we do, we will make sure that your privacy is protected and only use it for those purposes.

## Sharing your personal information

We do not sell, trade, or rent Users personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates and advertisers for the purposes outlined above.

## Changes to this privacy policy

Neville Construction Group has the discretion to update this privacy policy at any time. When we do, we will revise the updated date at the bottom of this page. We encourage Users to frequently check this page for any changes to stay informed about how we are helping to protect the personal information we collect. You acknowledge and agree that it is your responsibility to review this privacy policy periodically and become aware of modifications.
